Informal Hearings, Shared Meter Cases, Appeals and Rehearings

August 2003

Informal Hearing Unit

As of August 31, 2003 there were 70 cases in the informal hearing unit. During this month, 3 complaints were resolved with pre-hearing mediation, 10 informal hearings were scheduled, 5 were postponed or cancelled, 5 hearings were held, and 6 informal hearing cases were closed with written decisions.

Shared Meter Designee Cases

Under Section 52 of PSL (Shared Meter Law) only the Commission or its Designee can decide certain complaints. The majority of these cases concern the twelve-month charge assessed to owners for failure to find and correct instances of shared metering. At the end of August there were 162 shared meter complaints pending. Thirteen new complaints were received in August and ten cases were closed.

The designee reduced the twelve-month assessment to the minimum of 25% in seven cases. The twelve-month assessment was cancelled in one case due to extraordinary cost, and the charge was cancelled in one case due to the owner requesting the investigation. The owner was found to be responsible for the shared meter charges in one case.

Appeals and Rehearings

At its August 20, 2003 session, the Commission approved OCS's recommended determinations of three rehearing petitions. All three rehearing determinations concern decisions by the Commission's designee in shared meter service cases involving Con Edison electric service. Two determinations (one concerning cross petitions from the building owner and tenant, and the other concerning a petition from the tenant) uphold the designee's decision. The third determination (concerning a petition from the building owner) modifies the designee's determination by limiting shared area charges to the period following the owner's purchase of the building.

In addition, the Commission approved OCS's recommendation that a residential customer's request for rehearing of an appeal determination (concerning alleged overbilling by National Fuel Gas Corporation) be summarily denied for failure to state grounds warranting rehearing.

Two appeals were accepted for review during August. A residential customer appeals an informal decision concerning a service quality dispute with Verizon. Con Edison and an interruptible gas customer cross appeal an informal decision concerning rate classification. In addition, one request for rehearing of a shared meter decision by the Commission's designee and one request for reconsideration of such a decision, both involving Con Edison, were accepted.

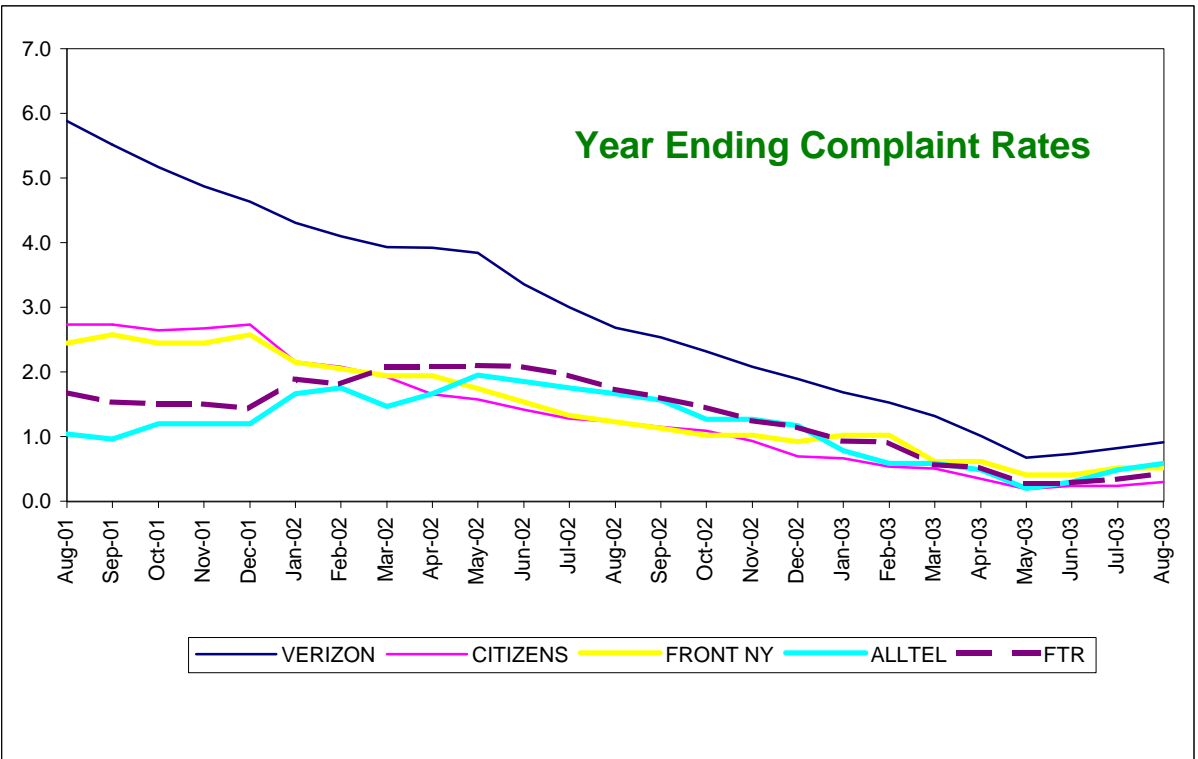
