With RG&E's *Voice Your Choice* program, you can choose your electricity supplier and decide whether you want to pay a *fixed* or *variable* price for your electricity supply.

This *Voice Your Choice* Enrollment Kit explains your Electricity Supply Pricing Options and how to *Voice Your Choice*.

Customer choice is required by New York State Public Service Commission policy in order to further competition. Under the *Voice Your Choice* program, which is part of a new RG&E rate plan approved by the PSC in May, RG&E customers are being asked to select an Electricity Supply Pricing Option for all of 2005.


You Can Choose Your Electricity Supplier

Your total electricity price is made up of supply and delivery charges.

The **supply charge** is what you pay to either RG&E or an energy services company (ESCO) for the electricity purchased on your behalf. Your **Voice Your Choice** selection will primarily affect the **supply** portion of your bill. You may want to contact ESCOs and compare their prices and services. A list of ESCOs is included in this kit.

Each Electricity Supply Pricing Option has an associated **transition charge**. The **transition charge** is built into your current electricity bill and is paid whether you receive electricity **supply** from RG&E or an ESCO. The majority of the **transition charge** represents the difference between the market price of electricity and the price of RG&E's mandated, long-term electric contracts. This charge will appear on a separate line in your bill beginning January 1, 2005.

Changes in Electricity Supply Pricing

Beginning October 1, 2004 you can choose to buy your electricity **supply** from RG&E or an energy services company (ESCO). Similar to the decision to finance a home, you have the option of choosing a variable or fixed rate for the electricity **supply** portion of your bill.

The variable supply price will fluctuate with the market price of electricity, while the fixed price will remain the same throughout 2005.

If you do not choose an Electricity Supply Pricing Option by 8:30 p.m. on December 30, 2004, you will be automatically enrolled in the Variable Price Option.

Note that the selected Electricity Supply Pricing Option will apply to ALL premises/addressees under a single Summary Billing Account.



>> **RG&E IS YOUR ENERGY DELIVERY COMPANY.**

The **delivery charge** is what you pay to RG&E to transport electricity over our power lines to your business. The **delivery charge** is a fixed price per kilowatt-hour (kwh) – it will not change – and is the same for each Electricity Supply Pricing Option.

RG&E will continue to safely and reliably deliver your electricity. If your power is interrupted or if you have questions regarding your **delivery** service, RG&E will be there for you.

Remember, with any Electricity Supply Pricing Option you select, your total electricity bill will change month to month depending upon your electricity usage.

Electricity Supply Pricing Options

Each option consists of a **supply charge** and a **transition charge**. These charges are either *fixed* – the same amount each month – or *variable* – changing on a monthly basis.

- >> FIXED PRICE OPTION** | This option from RG&E consists of a *fixed* **supply charge** and a *fixed* **transition charge**. The fixed **supply charge** includes the cost of electricity plus the costs of procuring electricity and managing the risk of providing a fixed price over the one-year period.
- >> VARIABLE PRICE OPTION** | This option from RG&E consists of a *variable* **supply charge** and a *variable* **transition charge**. The variable **supply charge** reflects the changing market cost of electricity in each month of the year.

>> ESCO OPTION WITH SUPPLY ADJUSTMENT

This option consists of an ESCO **supply charge**, a *fixed* **transition charge**, and a credit on your RG&E charges because you purchase your **supply** from an ESCO. The amount of the credit is based on the market price of electricity in each month of the one-year period.

>> ESCO PRICE OPTION

This option consists of an ESCO **supply charge** and a *variable* RG&E **transition charge**.

Electricity Price Components

Today, your RG&E bill has **delivery, supply and transition charges** “bundled” into one price. However, beginning January 1, 2005, when your new Electricity Supply Pricing Option will take effect, these charges will appear as individual items (“unbundled”) on your bill.

Be sure to compare all your charges (**delivery, supply and transition charges** as well as any **supply** adjustment, if applicable) to determine your total electricity cost. Prices are rounded to the nearest one-tenth of a cent and do not include applicable state and local gross income taxes.

Questions to Ask an ESCO

- ▶ What is your charge per kilowatt-hour (kwh) for electricity **supply**?
- ▶ Is this a fixed charge or does it vary depending on market price, time of day or usage?
- ▶ What is the length of the agreement?
- ▶ What procedures are in place if I have a question or a complaint with you as my new ESCO?
- ▶ Is there a security deposit, cancellation fee or other fees?
- ▶ Do you have any incentives for signing up with you?
- ▶ Do you guarantee savings?
- ▶ When will I be billed for electricity and are your charges included in my RG&E bill?

What If You Change Your Mind After

January 1, 2005?

During the one-year period, January 1, 2005 through December 31, 2005:

- ▶ You can switch anytime from the RG&E Fixed Price Option to the ESCO Option with Supply Adjustment.
- ▶ You can switch anytime from the Variable Price Option to the ESCO Price Option.

If you do not choose an Electricity Supply Pricing Option by 8:30 p.m. on December 30, 2004, you will be automatically enrolled in the Variable Price Option and will not be eligible to change to a fixed price option until January 1, 2006. Your electricity service will not be interrupted.

How to Enroll

To enroll in an RG&E Electricity Supply Pricing Option:

- ▶ Mail the enrollment card provided in this kit.

When enrolling, it's important to have your **RG&E** account number handy. Your account number is located in the top right corner on the first page of your bill.

To enroll in an ESCO Electricity Supply Pricing Option, contact the ESCOs in this kit. If you purchase your electricity supply from an ESCO, your ESCO will enroll your account for you.
