**NOTICE OF INTERVENTION
OF THE PUBLIC SERVICE COMMISSION
OF THE STATE OF NEW YORK**

On February 10, 2005, the Federal Energy Regulatory Commission (FERC or Commission) issued an "Order on Compliance Filing and Rehearing and Establishing Section 206 Proceeding" (Order) directing PJM Interconnection, L.L.C. (PJM) to file an explanation of why PJM's interconnection restudy provisions should not be governed by the standards in FERC's Order No. 2003 (Standardization of Generator Interconnection Agreements and Procedures). The Order also requested that interventions be submitted within 21 days of PJM's filing. On March 28, 2005, PJM submitted its response to the Order, and proposed to revise its tariff to adopt the criteria in Order No. 2003 for conducting a re-study.

The New York State Public Service Commission (NYPSC) submits its Notice of Intervention pursuant to the Order, the Notice of Extension of Time issued on March 14, 2005, and Rule 214 of the Commission's Rules of Practice and Procedure.
