NOTICE OF INTERVENTION

On April 16, 2007, the New York Independent System Operator, Inc. filed proposed tariff changes to provide compensation for the increased costs incurred when generators are required, pursuant to local reliability rule, to switch from gas and utilize a minimum level of an alternative fuel, usually oil. This local reliability rule, which is applicable to New York City and Long Island, is designed to avoid a loss of electric load, under certain load conditions, if a single gas facility becomes unavailable. The New York State Public Service Commission hereby submits its Notice of Intervention in the above-captioned proceeding pursuant to the Commission's Notice of Filing issued April 16, 2007, and Rule 214 of the Federal Energy Regulatory Commission's Rules of Practice and Procedure.
