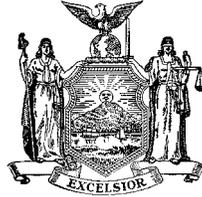

INTRODUCTION

On April 14, 2006, the New York Independent System Operator, Inc. (NYISO) filed proposed revisions to its Market Administration and Control Area Services Tariff to modify capacity market rules for intermittent power resources and limited control run-of-river hydro resources. On April 27, 2006 the Federal Energy Regulatory Commission (Commission) issued a Combined Notice of Filings #1, (Notice) inviting interventions or protests by May 5, 2006.
