NOTICE OF INTERVENTION

On May 1, 2007, the New York Independent System Operator, Inc. filed proposed revisions to the liability limitation provisions contained in its Open Access Transmission Tariff ("OATT") and Market Administration and Control Area Services Tariff ("Services Tariff"). The proposed changes would make the OATT and Services Tariff consistent with one another, as well as with the liability protections that have been afforded to other Independent System Operators and Regional Transmission Organizations.


