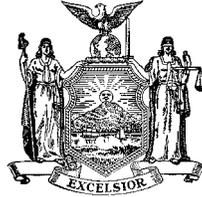

**MOTION TO NOMINATE NEW YORK CHAIRMAN WILLIAM M. FLYNN
TO NORTHEAST REGION JOINT BOARD**

On September 30, 2005, the Federal Energy Regulatory Commission (Commission) issued an Order in the above-captioned proceeding seeking to convene Joint Boards on Economic Dispatch, as required under the Energy Policy Act of 2005, §223. Under this section, the Commission is required to convene joint boards on a regional basis "to study the issue of security constrained economic dispatch for various market regions, to consider issues relevant to what constitutes security constrained economic dispatch and how such a mode of operating. . .affects or enhances the reliability and affordability of service and to make recommendations to the Commission."

The Order requests that each state nominate and submit to the Commission the name and contact information of one representative for the appropriate joint board no later than two weeks after September 30, 2005.

The New York State Public Service Commission (NYPSC) submits its Motion to nominate William M. Flynn, Chairman of the

NYPSC, to the Northeast Joint Board pursuant to the September 13, 2005 Order Convening Joint Boards Under §223 Of The Federal Power Act. The NYPSC is pleased to take part in this endeavor and to work with the Commission and the Department of Energy to meet their duties under the newly enacted Energy Policy Act of 2005. Chairman William M. Flynn is committed to actively participate in the Northeast Joint Board in order to meet the Commission's timetable to submit its Report to Congress on the Joint Boards' recommendations on or before August 7, 2006.
