NOTICE OF INTERVENTION

On December 1, 2006, the New York Independent System Operator, Inc. filed revisions to its Market Administration and Control Area Services tariff, including: 1) provisions for an additional 500 MW of intermittent resources, such as wind generators, to receive special payment provisions and penalty exemptions; 2) an exemption, for generators conducting equipment tests, from persistent undergeneration charges; and, 3) an exemption, for 499 MWs of generation providing steam into New York City, from the 10-minute Non-Synchronized Reserve offer requirement otherwise imposed on Installed Capacity suppliers. The New York State Public Service Commission hereby submits its Notice of Intervention pursuant to the Federal Energy Regulatory Commission's (Commission) Combined Notice of Filings #1 issued December 6, 2006, and Rule 214 of the Commission's Rules of Practice and Procedure.


